REPORTS

Update from Chief:

- The gate installation is moving along as planned. The footing is done for the track. Brown's Supply and 711 will be making donations for the installation of a street light at the site.
- The interior cameras have been installed. Five are inside over the doors and three are ceiling mounted in the main station building for a total of eight.
- Damon has completed an application for a \$15,000 no funds matched grant. If awarded this will be used for brush pants, jackets, and helmets.
- We are awaiting word on the awardment of the CalFire grant.
- The lights on the ambulance are still not working correctly. An estimate was received from EVS
 but the Board would like to have a quote from BlackPoint LLC. BlackPoint would be able to do
 the work without taking the ambulance out of town. Damon would like the estimate to include
 all new LED lighting for the vehicle.
- Three EMT's have passed the national test and are moving forward for reimbursement.
- The Board requested reporting from TLV Services for actual amount collected from their billing services VS amounts invoiced. Joanie will request.
- Action Item for next month: Review of hourly pay for service worker to maintain our trucks and equipment.
- It is possible that we may have a regular commissioners meeting at the firehouse for July.

- Auditors' request: We have submitted all information. We will receive a report when the audit
 is complete for us to sign off on and then we will receive the report which will confirm all
