Update from Chief:

- Damon briefed the Board on the Airport Fire.
- CalTech recently inquired about making a donation to the District in the amount of \$20,000 as they were in the line of the fire but had no damage. We are grateful that they would like to make this donation, but Damon feels that it should be shared by all nine departments that responded to the Airport Fire. All of the departments, but one, would like to donate their funds to the training center in Bishop. With these funds it will be possible to purchase a "burning car" prop for all to learn from at a cost of \$25,000. The donation of \$17,777.84 will go to the Bishop Training Center and the local departments will cover the remaining cost.
