- The Board has reviewed our Conflict of Interest Code as required by government code Section 87306-5 and have determined that no changes are needed at this time. A motion was made that the code be accepted as written.

- Damon has been directed by the Board to move forward with pricing and possible installation of an electric/timed gate at the rear entrance of the firehouse parking lot. We are seeing an increase of traffic through our driveways of unknown vehicles and pedestrians. This is causing a concern because of the recent theft of radios. More information will follow in April.
- Scott Stoner, our technical staff, gave a brief description on security cameras for the interior of
 the buildings and their cost. He feels this would be a good addition to our security. A motion
 was made giving Scott \$4000 to proceed with the purchase of cameras along with the necessary
 equipment to make it an inhouse system.

REPORTS

Update from Chief:

- The theft of four radios is under investigation by the Inyo County Sheriff's Department.
- The EMT class is still moving forward but at different locations with the Covid 19 virus.
- The weather station has been installed and Damon is hoping to put a link on our District web site for community use.
- Dave Calloway is out of town for a medical emergency with no return date known. At this time
 we have no EMT's to respond during the day. CalFire has agreed to be on standby from 10-4
 daily to assist with this problem. Bishop Fire has also offered their assistance.
- Damon has been given direction on how to respond to an emergency scene with the Covid-19 virus. He has passed this information on to all members of our department.
- The CalFire Grant was opened today. Work shall begin to complete the application and apply.
- Damon believes that we should begin to include funding for new door locks in our yearly budget as these locks and software can no longer be supported. This could be an expensive item in our budget.
