DEPARTMENTAL BUSINESS/ACTION ITEMS

- Greg has been working with County Counsel on the agreement with the Big Pine Paiute Tribe for
 Fire Protection as the Board would like to update this agreement. This is the first review and
 request for corrections and additions/subtractions. To show how the fee is calculated, Greg
 would like to place the formula in the agreement. Damon would like to see an end date for
 negotiations/renewal. Cheryl Levine or Sarah Vance, of the Big Pine Paiute Tribal office, shall be
 contacted to set a date for review of this agreement. This shall be placed on the agenda for the
 October meeting.
- Water tender #8 is in need of an engine brake. A motion was made that will allow Damon to purchase and install an engine brake not to exceed \$3000.

Replacement of engine #2315

After a long quest looking for a replacement and with finding nothing that would be an effective replacement, Damon has found an HME, OES, Type 6 Truck in Anaheim CA. A new unit at an estimated cost of \$242,000 plus tax and licenses bring the cost to approximately \$261,000. Damon feels that we can sell 2315 for \$20,000 to \$25,000. This new unit must have an engine brake installed before the unit goes into service if one is not included in the purchase. A motion was made to enter into an agreement to make the purchase of this vehicle with \$100,000 down payment and financing the remainder. A special meeting will be held on Thursday, September 17, 2020 to discuss the final decisions on the financing.

Wildland Supplies

Damon would like to purchase 25 Red Bags, 25 Red Blankets/Tarps, 13 Sleeping Bags, and a set of blue pants for our firemen for use on wildland fires. He estimates that the cost could be around \$10,000.

Wildland Grant

We have received a \$10,000 Foundation Grant that will be placed into our Wildland budget. Damon would like to order a set of blue turnout pants and a set of yellow shirts to respond to wildland fires with these funds.

- Lights for Sierra 35 should be installed next week.
- Hi-Tech asked that no more hose testing be done from the trucks. It is felt that this could be why our pumpers need servicing so often.

Blood pressure machine

Scott Stoner is assisting Dave Calloway in the selection of the new machine. Dave feels that we should be able to get a nice machine for under \$4000 with Scott's help and expertise.

• Several of our firemen attended to thank the Board for giving them the opportunity to respond to wildland fires out of our area with good equipment and supplies. Paul Huette, Mykala Howard, and Victor Alcala responded to the Slink Fire in the Coleville Walker area. They were on a strike team with Lone Pine, Bishop, and Independence. They felt that they presented a united front and were willing to help the community when and where they were needed. They felt proud and honored to represent the Big Pine Fire Protection District. They worked with the same crew that responded to our Taboose Fire and felt proud and honored to represent the Big Pine Fire Protection District with men that they knew.
