Wildland Budget

The Wildland budget, #830501, will need to be increased by \$40,000 to meet payroll making the total budget amount \$396,462. The increase shall be placed as follows: \$36,800 shall be added to object 5012 and \$3200 shall be added to 5021 for payroll. The Ambulance budget will be reviewed next month if necessary.

• Lucas Auto CPR by Stryker

Damon made a presentation to the Board on a Lucas CPR machine. Damon and Dave believe that this machine is a more user-friendly option for our EMT's and firemen to use. Unlike the Auto Pulse, the EMT's can train with this machine. The cost of this machine is \$25,090.24 with a four-year payment plan of \$6,272.56 each year. The Maddy Grant will assist with the payment for this purchase. A 7-year warranty is included. A motion was made that this machine be purchased and Damon will submit as part of the Maddy Grant application.

Garage Door Replacement

Allen's Construction serviced the garage doors on the wild land bay. He has found that they are showing their age of 30+ years as the springs and the door openers are wearing and this could cause the doors to not open. The cost to replace doors and openers will be approximately \$17,940. A deposit of \$16,140 has been requested but this will need to be confirmed. This purchase shall be taken from the ACO account.

REPORTS

Update from Chief:

- The Maddy Grant is due at the end of November. The application will be completed for the following purchases: the Stryker gurney, Lucas Auto CPR machine, EDispatch, Cross Connection and Frontier internet. Damon is hoping for funding of at least \$20,000.
- The side by side is now at 395 Auto Body for painting. Nate Dondero has agreed to donate the lights and Eddy's Upholstery is repairing the seats. Greg will be doing any lettering that is needed. A radio will be installed for communication. A trailer will need to be purchased for transportation. Jeff Coffman will be doing the training for anyone who will be driving this vehicle. Training will be a requirement to operate.
- The programmable extra door lock/handle has been received from Robert Skeels & CO.
- Truck 2313 is in Reno for repairs to the transfer case and power steering. Damon has requested that a
 preventative maintenance inspection be done while it is at Silver State.

• Damon presented a quick overview of the income for the District over a four-year period. These monies have been placed in the Wild land Budget. He reported a net income of \$533,816.75 and a gross income of \$1,270,588.06. He feels that it may be time to begin looking for a new type 2 engine to replace #6 because of this increase in revenue. If there is a purchase to replace #6 we will be able to invoice for forest service fires. At this time, we cannot invoice for this truck on forest service fires because they are the registered owners. Damon does invoice for the personnel that respond on this truck.
