DEPARTMENTAL BUSINESS/ACTION ITEMS

Repair on Truck #7

Truck #7 was responding to the Dexter Fire at Bald Mountain when the transfer case would no longer operate. It was towed to Silver State International Trucks by Silver State Towing at a cost of \$3300. The problem has been diagnosed and parts ordered as the repair is an emergency. A motion was made to complete the repair on #7 at a cost not to exceed \$25,000. This shall be taken out of the wildland budget.

REPORTS

Update from Chief:

- Wildland Fire Coverage: We sent truck #6 to the Dexter Fire instead of #7 because of the breakdown. At
 this time we have responded to ten (10) wildland fires either man made or made by nature. Damon is
 expecting calls for equipment again soon as there is limited resources available for assistance.
- New #5 will be going to the Ford dealership in Ridgecrest on August 4th for the recall repairs. These repairs are on the backup camera and the drive line. He is hoping that a loaner car is available for the return home.
- Damon would like to inquire about increasing our credit limit on the VISA card to \$20,000. With the
 increase in wildland fires, there could be an increase in traveling expenses and this may be needed. A
 motion was made to increase the limit as high as possible for emergency situations. If we cannot increase
 the limit it may be necessary to inquire about an additional card.

- Several trucks, representing Big Pine Fire Department, escorted fireman Bryan Miller home for the last time. His memorial service was very nice. Food was provided by Copper Top, Two Brothers Pizza, and Country Kitchen. A motion was made that we need to show Two Brothers Pizza our appreciation for all that they do for the Department as they make donations any time that food is needed.
- The CalFire Foundation Grant was applied for and awarded in the amount of \$10,000. These funds shall be used to purchase a drone and magnet lights.
- The Alert Wildfire cameras are in operation. The website "Alertwildfire.org" is operating through us at an income of \$750 per month. These funds shall be used for anything that needs to be updated and/or replaced on the system.
- The door locks are programed and ready for installation.
- A refrigerator will be purchased soon and placed in the wildland bay. Damon hopes to purchase a damaged one from Sears or High Country Lumber at a reduced rate.
- Damon will be purchasing two new laptop computers and putting in for reimbursement.
- The passing of Clint Quilter, Inyo County Public Works Director, was noted.

Update from Commissioner Chairman Greg Bird

A discussion was had in regards to the depreciation of our equipment on our capital asset list. He was
directed to keep it simple and easy. He will move forward with the building of an spreadsheet to do so.
