DEPARTMENTAL BUSINESS/ACTION ITEMS

EMT Reimbursement Increase:

The EMT that is completing the "Notebook" or patient input should receive an increase in pay. This is due to the reasoning that it takes more time for reports to be completed and the person should be compensated for this. This person will be indicated as the primary caregiver in the computer and shall be the one to receive the pay of \$50 for that incident. A motion was made that this increase take effect on March 1, 2021.

Air Compressor:

The awarding of the bidding for the air compressor, which has been salvaged, is awarded to Dave Calloway for a price of \$75.

Locks

Damon would like this to be returned to the March agenda as he is awaiting information.

VPN for firehouse:

Virtual Private Network – this will be used as a gateway to remote access to the firehouse computer system. This is a way to have safe remote access to all computers. Scott's recommendation is that we use a Windows Pro computer as a server. The computer will have an estimated cost of \$600 with a battery backup that will have an estimated cost of \$250. A motion was made that Scott will have a budget not to exceed \$1000 for this computer and battery backup.

• High Speed Internet:

Stable internet would be a big advantage. The up's and down's of the system is causing problems with our computers, cameras, etc. Scott has been in contact with Frontier regarding the installation of a dedicated line with a bandwidth of 40 mg down and up. This will assist with downloads and uploads of information. The cost of this line would be \$320 per month. This includes a \$200 monthly discount. A possible funding source could be the Maddy Grant but we have had a request to wait until August if we want the Maddy Grant to assist with this. It can be a service that we use more quickly but the

Department will be fully responsible for the monthly payment until the Maddy Grant is funded. There will be no installation fee. More information will follow regarding a contract time limit. A motion was made that Scott Stoner pursue entering into a contract with Frontier for a stable high speed internet connection for \$320 per month with a 1 year contract. Scott was asked to move forward and not wait for the Maddy Grant funding.

LED Lighting:

Darren Pagenkopp of Pagenkopp Custom Construction has given a quote of \$2845 for the relighting, with LED lights, of the ambulance bay. A motion not to exceed \$3000 was made to replace the lighting.

VGA Grant

Damon would like the Boards approval to apply for the VGA Grant as many of our SCBA bottles are nearing the end of their life span. This life span is 15 years or 3 hydro tests. If we do not receive this grant, we will need to purchase bottles in Sept/Oct. A motion was made that Damon proceed with the grant process.

SCBA Bottles:

The purchase of new bottles could be as much as \$2000 per bottle. Damon has found a source for new bottles, but not "Scott" bottles, at a cost of approximately \$615 per bottle. This could be a budget item for next year.

Hose Machine:

Bishop would like us to help with the purchase of a 1" hose repair machine. A motion was made that we assist with this purchase not to exceed \$2000.

REPORTS

Update from Chief:

Mt View Fire:

The repairs caused by the wind at the fire have been completed. One more submission needs to be completed for reimbursement. This should bring all equipment back in good repair. The funds should arrive soon.

Wildland Overview:

March is wildland fire month. Emphasis will be on training for wildland fires.

Update 2315:

The pump panel controller is being replaced. Several small repairs have been made or need to be made and should be done soon.

Maddy Grant:

The grant has been completed and receipts have been submitted.

VFA Grant:

The paperwork has been submitted and we are awaiting funding of the grant. COVID has made it hard to order and receive product so it has taken longer than expected.

• Forest Service MOU:

Forest Service is trying to renegotiate their rates statewide. Inyo and Mono Counties are refusing to sign at this time. CAL OES is not promoting this renegotiation.

Drivers Training:

Big Pine and Bishop Fire Departments are developing a plan for drivers training for volunteers who would like to drive the engines. This will be designed for drivers that do not need a job related Class A or Class B license. The Department will cover the cost of the physical that will be required.

Information shared at the Chief's Meeting:

The State of California is now requiring inspections for schools, motels, hotels, high rises, etc. Big Pine has five businesses that will require this. Currently, Damon does not want to complete inspections as he would like to have the State complete the inspections and bill the business accordingly. There may also be a possibility that Bishop Fire may hire an inspector.
